Each Family Court judge will maintain a list for his/her division for appointments and are accepting applications. Those currently serving as GAL/Parent's attorneys will be "grandfathered" onto the lists in their current division but will need to resubmit an application as the new Supreme Court rule requires additional expectations. Applications submitted after (3/1/24) will not be reviewed until March 2025, and then every February subsequent.

Applicants must be in good standing with the Kentucky Bar Association and must agree, if selected, not to make a campaign contribution to any sitting judge serving in, or judicial candidate for Jefferson Circuit Family Division Court.
