Motion Hour for Family Court Division 9 shall be conducted telephonically through Free Conference USA beginning June 15, 2020 at 1:00 pm. **If you would like to attend in person you may however; it is recommended you attend remotely. You must wear a mask inside the courtroom at all times if attending in person Motion Hour.** The Conference call number for Family Court, Division 9 is **1-774-220-4000**. You will need to enter conference ID: 595-4736 **This Motion Hour is for SEPTEMBER 19, 2022**

- All motions shall contain the conference call number and conference ID number in the notice.
- The Conference call number and conference ID number is the same every week, it never changes.
- You **MUST** place your phone on mute until your case is called. There is no need to announce yourself when entering the call.
- Motions with a Pro Se litigant shall include the litigants telephone number and email address.
- Once your case is called, and heard, you may exit the call if you're not on any other case on Motion Hour.
- Please **do not** join the call to announce, "you have an objection and want your case to be called". This is to **your case to be called. Please include the case number, and all parties involved.**
- If you are to receive a hearing date, Shanetta will contact all parties directly outside of Motion Hour to discuss.
- If you log on before the Court, please keep personal conversations among each other to a minimum. Remember, there are others on the line.
